The issue of whether the modelling and simulation software to be offered under the Lot-1 Multimodal Transport Modelling Software (the modelling software) will be offered on a

permanent basis or through a rental method is causing confusion. The term "subscription," referenced in multiple clauses of the technical specifications, can lead to the belief that the software to be offered may be provided through an annual rental method. Due to the significant differences that can arise between permanent license prices and rental prices, it has become necessary to clarity how the licenses to be offered will be acquired by the Administration.

QUESTION-11:

ANNEX II + III: Technical Specifications, Lot 1- Transport modelling and simulation software, Item 1.1.28 - Documentation and technical support

Since the software to be offered are packaged software, widely used around the world, and because it is uncertain what kind of demands might come from the customer, it is not possible to make any changes to these software based on customer requests.
