Additional Information about the Contract Notice

Article 18. Selection criteria, 2) Technical capacity

Delete the text:

The tenderer has delivered supplies (proportion carried out by the candidate) under at least one contract with a budget of at least **EUR 50.000** in supply of external vehicle disinfection system (e.g. truck, train, plain) implemented during the reference period.

And replace with:

The tenderer has delivered supplies (proportion carried out by the candidate) under at least one contract with a budget of at least **EUR 50.000** in supply of external vehicle disinfection system (e.g. truck, train, airplane) implemented during the reference period.

Additional Information about the Contract Notice

Article 21. Tender opening session

Delete the text:

The tenders will be opened on 21/06/2021 at 10:00 a.m. local time at Hakkı Turaylıç Caddesi No: 5 B Blok Kat: 10 Emek, Çankaya/Ankara/Türkiye.

The opening session should be held at least one week after the deadline for submission of tenders. In the case that at the date of the opening session some tenders have not been delivered to the contracting authority but their representatives can show evidence that they have been sent on time, the contracting authority will allow them to participate in the first opening session and inform all representatives of the tenderers that a second opening session will be organized.

And replace with:

The tenders will be opened on 21/06/2021 at 10:00 a.m. local time at MoTI/DGEUAFR/EUID premises at the address: Hakkı Turaylıç Caddesi No:5 B Blok Giriş Kat Toplantı Salonu Emek / Çankaya / Ankara / Türkiye.

Only one representative of the each tenderers will be allowed to participate into the tender opening session due to the measures against the COVID-19 Pandemic. All participants shall deliver an authorization letter that shows clearly the identity of participant representing the potential tenderer. The authorization will be given with an official letter with letterhead for each person, duly stamped and signed by the persons that have the authority to represent the company. No notarial attestation is needed. The authorization letters shall be supported by the identity card, passport or driving license of the respective participant.

The Contracting Authority reminds that the Participants have to take necessary actions in accordance with the applicable decrees and circulars covering measures taken against the COVID-19 pandemic. Each participant has to wear a mask during the tender opening session. Each participant has to state the HES code (obtained from the mobile application spearheaded by the Health Ministry) at the entrance of the Ministry in order to show the health status.

Delete the text:

3.7. Application to relevant authorities for a subscription to utility connections such as electricity, water, etc. shall be under the responsibility of the contractor.

And replace with:

3.7. Application to relevant authorities for a subscription to utility connections such as electricity, water, etc. shall be under the responsibility of the TCDD. The contractor shall provide required assistance to the TCDD in obtaining all subscriptions.
