QUESTION 1:

Professional capacity

Regarding the Professional capacity (based on items 4 and 5 of the application form for service contracts and on items 4 and 5 of the tender form for supply contracts). The reference period which will be taken into account will be the last three years preceding the submission deadline. We kindly request if you can extend the time of 3 years for a time of at least 15 years?

QUESTION 2:

Given the situation regarding the Coronavirus outbreak for the last 1,5 years, the tender procedures were profoundly affected worldwide. Since there had been relatively less contracts/services during the pandemic, the reference period given as the last 3 years diminish the applicants' chances to present eligible references complying with the technical requirements. Based on these, we would like to kindly request an extension for the reference period and change the reference period to the last 5 year-timeframe.

ANSWER 1 and 2:

QUESTION 4:

As per the article IV.2.2) Time limit for receipt of tenders or requests to participate, the deadline for submitting tenders is stated as 04.08.2021. By considering the religious holiday and summer vacation period both in Turkey and in Europe, which is overlapping with Expression of Interest

preparation, we kindly request from the contracting authority an extension for the submission deadline of the application to submit the best possible offer.

QUESTION 5:

Due to intervening national and religious holidays, we kindly ask for a time extension regarding the deadline for requests to participate.

ANSWER 3 to 5:

may be implemented under different service contracts? Regarding the first technical criteria, it is understood that the references are required to contain trainings and capacity building activities. If that is the case, could you please clarify if there is a minimum budget requirement for training and capacity building activities implemented in the reference project?

Will contracts with budgets less than 350.000 also count as a reference if the total budget of contracts is over EUR 350.000; or does it mean that the same reference may be implemented under different service contracts? Regarding the second technical capacity criteria, it is understood that the references are required to contain organisation of events in the field of sustainable urban mobility. If that is the case, could you please clarify if there is a minimum budget requirement for the organisation of events in the field of sustainable urban mobility.

QUESTION 11:

It is indicated in the technical capacity criteria that "The candidate has provided services under at least 1 (one) service contract with a budget of at least EUR 350.000,00 (proportion carried out by the candidate) in development of sustainable urban mobility plans (SUMP), which was implemented at any moment during the reference period: 3 years prior to the submission deadline of this application." Is it possible to provide the minimum budget of EUR 350.000,00 as sum of multiple service contracts?

ANSWER 9 to 11:

The candidate is not allowed to meet the threshold of the financial value specified in the technical selection criteria by combining contracts with smaller financial value. In order to meet the technical selection criteria stated in the Article 18.3 of the Additional Information about the Contract Notice, Candidate must submit at least one (1) service contract with the minimum financial amount and the services specified in the technical selection criteria as reference.
